**Sub: Introduction of concessional Box Rate for
Stuffing/Destuffing of Containers at Mumbai Port.**

Hitherto Mumbai Port has been levying destuffing and stuffing charges on the containers for (i)

stevedoring and (ii) Port Labour engaged for the said operations separately. Users have been repeatedly raising concern about high stuffing/destuffing charges at Mumbai Port as compared to the CFSs at Navi Mumbai. Considering the demand of the users and to facilitate container stuffing/destuffing activities in the Port areas as also to attract more container traffic at this Port, the Board of Trustees in the meeting held on 22.08.2006 approved levy of a consolidated concessional rate being termed as BOX RATE for stuffing/destuffing of containers as under, as against the existing two separate charges levied for stevedoring and supply of Port labour.

2. The concessional consolidated BOX RATE will be effective from 11th September 2006 and will have to be paid in advance along with other container related charges as per enclosed formats. The above consolidated BOX RATE will be valid for six months from 11th September 2006 upto 10th March 2007 and will be reviewed thereafter.

3. You are requested to give wide publicity amongst all your members and customers to avail the benefit of aforesaid concession, especially for stuffing exports, for shipment through Mumbai Port.
