4	Investigation in the matter pertaining to your complaint regarding award of contract of lifting of well water, is still in progress and report is not yet prepared.



The period within which an Appeal could be preferred is 30 days from the date of this communication. The prescribed format of Appeal Petition is enclosed herewith.
