

	Ans:	The 5 th Oil Berth is to accommodate the vessels of sizes 70,000 DWT to 2,50,000 DWT. It comprises of Unloading Platform, Berthing/ Mooring Dolphins on either side of unloading platform and are interconnected with Catwalk bridge. The approach trestle connects unloading platform to land fall point at Jawahar Dweep and is 2.6 KM long, approximately.
b	Q	Copy of Environment Clearance for 5 th Oil Berth?
	Ans:	Copy attached (Annexure-I).
c	Q	Details of area being reclaimed in Jawahar Dweep?
	Ans:	Approximately 13 hectors of area is proposed to be reclaimed at South-West cove of Jawahar Dweep Island with available quantity of rock / soil from Mumbai Metro Project site.

	Ans:	Draft feasibility report is being prepared by M/s. EIL, about no. of tanks etc. will be known on finalization of the same.

	Ans:	Can be given on finalization of feasibility report.

f	Q	Capacity of each tank ?
	Ans:	Same as at (e) above.
g	Q	Products to be handed in this 5 th Oil Berth.
	Ans:	Crude Oil proposed to be handed in this berth.
