Sub : Provision of Advance payment to be collected
from Port Railway users.

With reference to the subject above, it is to inform that the Competent Authority of MbPA in the meeting held on 01/11/2022, had given directives for taking advance payments from all the port users for all the services to be rendered by MbPA.

In view of the above directives, the parties will have to make an advance payment of port charges and demurrage charges before the services to be rendered by MbPA. Hence, for all incoming rakes booked to BPTG/BPTV, an advance sum of amount be paid before the arrival of rake at MbPA premises. The parties are advised to make the advance payment immediately after generation of Railway Receipt at the originating station/booking station so that unhindered services of MbPA can be availed. Similarly, for all the outward rakes an advance sum of amount be paid to MbPA at the time of indent itself. An indent submitted without payment of advance sum will be treated as invalid.

The sum of advance mentioned above will include following charges.

For inward traffic	For outward traffic
i) Through Freight	i) Through Freight
ii) Terminal Charges	ii) Terminal Charges
iii) Siding charges (as applicable)	iii) Siding charges (as applicable)
iv) Storage fee, if required	iv) Storage fee, if required
v) Demurrage charges	v) Wagon Registration Fee (WRF), if online payment is not made directly to Central Railway
	vi) Demurrage charges

Note :

- i) Demurrage for 15 hours for flat wagons/container rakes and demurrage for 30 hours for other types of wagons will be collected in advance.
- ii) Storage fee considering occupation of 40 half bays (2800 sq. mtrs.) for 15 days for a rake irrespective of full or mini rake will be collected in advance. Applications for extension of storage will be treated as valid only if the advance payment for the period of extension for storage is made along-with the application of extension for storage.
- iii) If the indent is cancelled, WRF will be forfeited and remitted to Central Railway with GST. The charges collected towards Through Freight, Terminal Charges, Siding Charges and other port charges will be adjusted against the "demurrage on cancellation of indent" charge which is equal to 24 hours demurrage.

It is requested to give vide publicity of the above amongst all concerned.
