Sub: Levy of parking charges for open areas being used by transporters for parking of Cargo / Container Handling Equipments engaged in Docks.



In continuation to circular No. TM/M/9-1/8 dated 26.06.2020, it is to state that since the transporters have informed that they have paid full parking charges for the months of April and May 2020, as suggested by them, instead of giving exemption of 30% on the parking charges for the first two months, as a working arrangement, those transporters who have paid full parking charges for the months of April, May and June 2020, will be allowed to pay 70% parking charges for equal number of months during July, August and September 2020. This arrangement is being made as some of the transporters have already paid full parking charges for the month of June 2020 also.

2. We are also glad to inform that the Port has taken into consideration the efforts put in by the transporters in the port operations during the lockdown period and has unilaterally extended the exemption of 30% of parking charges for the month of June 2020 also, as intimated by referred circular dated 26.06.2020.

3. It is requested to inform your members about the same and to arrange to renew the Parking Passes of CHEs on or before 30.06.2020.
