Sub: Grant of extended free days for levy of demurrage

on import cargo & storage fees on containers/Malis.

Ref.: TM/M/13-5/Circular/36 dated 28.10.2022.

Vide Circular No.TM/M/13-5/Circular/36 of 95-96 dated 28.10.2022, the concessional scheme of grant of extended free days for levy of demurrage on import cargo and storage fees on containers/mafis was extended upto 19.11.2023 and was to be reviewed thereafter. The above facility is further extended till 19.11.2024 and the same will be as under.

## A) FREE DAYS FOR CARGO: IMPORT CARGOES-BREAK BULK AND CONTAINERIZED.

Sr. No.	Cargo	Recommendation for Free days
1	Containerized cargo	5 calendar free days following the date of vessel completing discharging operation.
2	Other import cargo	6 calendar free days following the date of vessel completing discharging operations.
3	Non containerized transshipment cargo	NIL *

## B) FREE DAYS FOR CONTAINERS/MAFI'S: (IMPORT/EXPORT)

Sr. No.	Type of Containers	Recommendation of Free days
1	Loaded Import Containers/Mafi's	03 days from the date of completion of vessel's import operations.
2	Loaded Export Containers/ Mafi's	05 days from the date of stuffing of containers at Port's CFSs or from the date of bringing in of fully loaded containers in Port premises.
3	Empty Containers	03 days from the date of completion of vessel's import operations or from the date of receipt of export Containers.
4	ICD containers	NIL **
5	Transshipment loaded / Empty containers & Export containers brought under Shipping Bills by sea from other ports for shipment.	05 days from the date of completion of vessel's import operations.
6	Empty Mafis	7 days from the date of completion of vessel's import operations.
