**Sub: Revised comprehensive Scale of Rates of
Mumbai Port Trust effective from May 01, 2019.**

In terms of Tariff Policy, 2018, the existing SOR will be allowed to be indexed annually to inflation to the extent of 100% of the variation in Wholesale Price Index (WPI) announced by the Government of India occurring between 1st January of previous year and 1st January of the relevant year. Such automatic adjustment of SOR will be allowed subject to the achievement of the performance standards specified in the SOR.

2. TAMP vide its email dated March 29, 2019, has requested the Major Port Trusts to index their Scale of Rates (SOR) by applying an indexation factor of **4.26 %** for the year 2019-20 subject to achievement of committed Performance Standards during 2018-19.

3. Accordingly, Section 2.17 of SOR pertaining to **Composite Berth Hire Charges and Cargo Related Charges** at Section 3.1(A), 3.1(B), 3.1(D), 3.3(A)(I)(II) & (V), 3.3(B), 6.2, 6.3 of SOR for **Dry Bulk Cargo** only, will stand revised and the new rates (as enclosed) will be effective from May 01, 2019.

4. The revised scale of rates will be published on website "www.mumbaiport.gov.in".

5. It may please also be noted that payment of advance deposit and billing towards all charges will have to be made as per the revised rates effective from May 01, 2019.

6. Further, Mumbai Port Trust's proposal for Revision of Scale of Rates is under process by TAMP. However, TAMP has issued instructions to continue with the present tariff till September 30, 2019 or revised order to be issued by TAMP on the proposal of MbPT, whichever is earlier.
