Sub: Grant of extended free days for levy of demurrage on import cargo & Licence (storage) fees on containers / Mafis.

Vide Circular No.TM/M/13-5/Circular/22 of 95-96 dated 20.11.2020, facility of free days for Licence (Storage) fees on import cargo and containers for one year from 20.11.2020 to 19.11.2021, was conveyed as under:

A) **FREE DAYS FOR CARGO: Import Cargoes - Break Bulk and Containerised.**

Sr. No.	Cargo	Free days
1	Containerised cargo	7 calendar free days following the date of vessel completing discharging operation.

Sr. No.	Cargo	Free days
2	Other import cargo	6 calendar free days following the date of vessel completing discharging operations.
3	Non containerised transshipment cargo	10 calendar free days following the date of vessel completing discharging operations.

B) FREE DAYS FOR CONTAINERS – (Import & Export):

Sr. No.	CATEGORY	FREE DAYS
(i)	Loaded Import Containers	5 days from the date of completion of vessel's import operations.
(ii)	Loaded Export Containers	15 days from the date of stuffing of containers at Port's CFSs or from the date of bringing in of fully loaded containers in Port premises.
(iii)	Empty Containers	7 days from the date of completion of vessel's import operations or from the date of receipt of export containers.
(iv)	ICD Containers	15 days from the date of completion of vessel's import operation or from the date of receipt of export containers.
(v)	Transshipment-loaded/ Empty Containers & Export Containers brought under Shipping Bills by sea from other ports for shipment.	15 days from the date of completion of vessel's import operations.


Note : The free days are calendar days and in computing number of free days, Dock holidays, Sundays, Custom holidays shall be included.

2. Further, vide Circular No.TM/M/13-5/Circular/40 dated 10.02.2021 free days for containers as noted above was also made applicable for Mafis. This facility was applicable till 19.11.2021.

3. In order to attract fresh cargo / containerized traffic, it has been decided that the facility as conveyed under abovesaid Circulars dated 20.11.2020 and 10.02.2021, for grant of extended free days for levy of demurrage on import cargo and licence (storage) fees on containers and Mafis will be extended for a further period of six months i.e. from 20.11.2021 to 19.05.2022.

4. The Port users are requested to take note of the above and avail of this facility and bring more and more cargoes to Mumbai Port.
