CIRCULAR

Sub: Dumping of Dredge material.

In order to streamline procedure and to ensure that dredge material is dumped at designated dumping ground all stake holders are instructed to comply with the following instruction:

- i) The company / firm that requires to carry out dredging has to apply to Mumbai Port Trust giving details of expected quantity i.e.to be dredged, name of the contractor and the equipment of the contractor.
- ii) Mumbai Port Trust will designate dumping ground area according to the quantity i.e.to be dredged.
- 'Flood Dumping ground area' is outside IV limits hence barges utilised for dumping should be under class and suitable clause has to be incorporated in the tender. All barges utilised for dumping should be self-propelled with AIS
- iv) Master of the barge should inform VTS prior dumping so that actual position can be verified by VTS.
- v) All companies may consider to incorporate suitable clause in tender/work order "payment will be carried out subject to verification or penalty will be levied if dumping is not reported to VTS".
