- Only TRACES Registered users can Download 197 Certificate from 2018-19 onwards.
- Deductor can download 197 certificate after received approval from AO.
- Deductor can check their "Inbox" option of "Communication " tab to download 197 Certificate.
- Deductor can also view or download 197 Certificate from "Download 197 Certificate "option available under "Downloads" Menu.

Step 1. Login on Traces website .

Step 2. Click on "Inbox" Under Communication Tab.

Step 3: Select Category of Communication: 'Certificate U/S 197,206C' then click on 'Go' button. Communication detail will be

appear on the screen under action required option.

Step 4: Select the row of 'Issuance of Certificate' then click on 'Download Certificate' button to download Certificate. User can

view Communication Category details after clicking on 'View Details' button.
