This has reference to your online RTI application dated 27.01.2023 seeking information regarding Revisiting/Revising Seniority and Promotions only of retired employees during the period 30.01.1997 to 31.12.2021 in the cadre of Asstt. Office Supdt. and Asstt. Shed Supdt.,

2. Accordingly, assistance of the office concerned of the Traffic Department has been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

SBIN0000300. If, payment made online, it is requested to intimate in writing to this CPIO, about details of the payment such as Date, UTR No./Transaction Reference No., Amount, immediately.
