Sir,

With reference to your RTI application dated 02.11.2020 you have sought information regarding water levy charges paid by M/s. Harbour Water Supplier Co. Pvt. Ltd for loading water of MCGM in his barges from Lakri Bunder, North, Darukhana during the period from 25.04.2015 till 02.07.2020.

2. Accordingly, assistance of the concerned office of the Traffic Department has been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

3. On the basis of the information received from the concerned officer of Traffic Department the information / reply is as under :

M/s. Harbour Water Supplier Co. Pvt. Ltd., have paid charges for supply of water as per Scale of Rates till 05.03.2020 for loading MCGM water through underground pipeline from Lakri Bunder North, Darukhana, Mumbai. Certified photocopies of the relevant book nos. towards charges paid for supply of water (details given below) are ready.

The same can be provided on payment of additional payment of Rs.24/- (12 page x Rs.2/- = Rs 24/-).

The required documents will be provided on payment of said amount.
