**Sub : Grant of concessional free days for Import /
coastal consignments of Iron & Steel –
Extension of.**

Ref : This office circular No.TM/M/13-5/Circular/36
of 95-96 dated 06.01.2021

By circular dated 06.01.2021 referred to above, the free days (concessional scheme) for large volume of import / coastal consignments of Iron and steel for the period of 20.11.2020 to 19.11.2021 was conveyed as under –


- (i) 07 calendar free days, following the date of vessel completing discharge, in case the aggregate quantity of consignments of Iron & Steel brought by the same vessel by a consignee is between 10,000 tonnes and 20,000 tonnes;
- (ii) 10 calendar free days, following the date of vessel completing discharge, in case the aggregate quantity of consignments of Iron & Steel brought by the same vessel by a consignee is above 20,000 tonnes and upto 30,000 tonnes;

(iii) 14 calendar free days, following the date of vessel completing discharge, in case the aggregate quantity of consignments of Iron & Steel brought by the same vessel by a consignee exceeds 30,000 tonnes.

2. In order to encourage importation of large volume of Iron & Steel cargoes through Mumbai Port and to attract more import / coastal traffic, it has been decided to continue the abovesaid facility of extended free days for import / coastal consignments of Iron & Steel (informed by Circular dated 06.01.2021) for a further period of one year from 20.11.2021 to 19.11.2022.

3. All Port Users are requested to take note of the above and avail of the facility and bring larger volumes of Iron & Steel cargo to Mumbai Port.
