3.	What is the average total number of employees employed by MBPT during 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19?	Vide letter dated 20.11.2019 RTI application has been partly transferred to General Administration Department of Mumbai Port Trust to provide information directly to you.

4.	During the last 5 years how many employees of Mumbai Port accepted the VRS offered by the MBPT?	Mumbai Port Trust have not offered VRS to its employees during the last five years.
