1. Report copy of the Details of Lands encroached in Maharashtra.	Pt. No. 1 & 2: Land/Area encroached: - Area between UP & DN Main Line, West side of Down Main Line and East side of Main Line below Wadala Flyover Bridge from Gate No. 5 to Signal RVJ S-23, Raoli Junction.
2. Report copy of the steps taken by the Government to evict the encroachment.	The Plot detail format of the encroached area is forwarded to the Chief Security Officer, MbPT for arranging encroachment removal programme. Also, 12 hours' notice is issued to the encroachers under MbPT General Bye Law No 9 to evict the area. The letters written to the Chief Security Officer, MbPT for arranging encroachment removal programme along with the Plot detail format and other attached documents can be made available to you on payment of Rs. 82/- (41 pages @ Rs. 2 per photocopy).

3. Report copy of the steps taken to protect the land of Port Trusts.	Pt. No. 3: Please refer The Chairman, MbPT's order dated 30/01/2017, regarding safe upkeep of Port land and removal of encroachment from the Port areas. The copy of the order dated 30/01/2017 can be made available to you on payment of Rs. 6/- (3 pages @ Rs. 2 per photocopy). After removal of encroachment, the land/area is handed over to the private Security firm for its protection and thereafter monthly inspection report is forwarded to the Chief Security Officer, MbPT for further necessary action at their end.


