

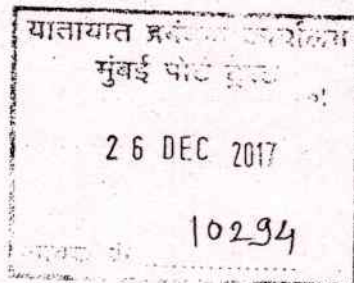

3 If the Custom Authority/Port is unable to dispose of those 14 cars within a period of two months from today, the Custom Authority and Port shall hand over the said 14 cars to the Official Liquidator who shall take steps to dispose off the same.

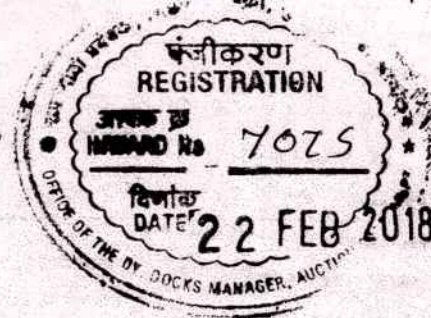
