**Sub : Revised System Procedures (SP) for New/Renewal
of Registration for issuance of Dock Entry
Permits (DEPs) - 2022**

Ease of Doing Business (EODB) is a primary focus area of Government of India and Mumbai Port is committed towards the process simplification, which is an important aspect. Accordingly, some of the documents required have been reduced and specified time of processing of application file for new/renewal of registration at Permit Section has been reduced.

In continuation of circular no. TM/P/19-15/03 dated 08.04.2022 amendments are made in Revised System Procedure SP as under:-

"In lieu of notarised copy of Leave & License Agreement, Port user can submit self-certified copy of Receipt of Submission of Leave & License agreement to the Sub-Divisional Registrar of State of Maharashtra also showing payment of registration fees and self-certified copy of registered Leave & License Agreement registered with the said authority"

System Procedures (SP) along with formats required to be submitted for New/Renewal of Registration for issuance of Dock Entry Permits (DEPs) is revised and made available on MbPA Home Page www.mumbaiport.gov.in under 'Quick Links - Revised System Procedures (SP) for New / Renewal of Registration for issuance of DEPs-2022'. The Port Users are advised to submit their application to Asstt. Traffic Manager, Permit Section as per revised System Procedures (SP) available on website at the time of New/Renewal of Registration of their company.

You are requested to give wide publicity amongst your members for smooth and expeditious processing of their applications for New/Renewal of Registration of their company.
