Sub : Nomination of area for storage of import cargo of
Gypsum, Ammonium Sulphate, MOP, MAP, DAP and
other such bulk cargoes under Section 3.3(A)(II) of
Chapter III of Scale of Rates and GBL.

Vide Circular dated 26.02.2019, Temporary Sheds 'A', 'B' and 'C' at
MOD Open Yard (area admeasuring 12000 sq. mtrs. approx.) were nominated
for storage of MOP cleared from Docks/Bunders.

2. Vide circulars dated dated 03.12.2019, 27.12.2019 and 05.04.2021,
Temp Shed 'C', 'B' and 'A' respectively were also nominated for storage of
Ammonium Sulphate cleared from Docks/Bunders.

3. Vide Circular dated 16.03.2021, the approval of Board was conveyed for extension of the facility of storage of MOP and other such bulk cargo in outlying areas for a period of 180 days. Also for Gypsum cargo, it was conveyed that Board has approved to continue to give further 60 days beyond abovesaid 180 days (240 days in all). Further, rates applicable for above as per SOR and GBL were also conveyed. This scheme is valid till 15.03.2022.
4. In view of demand of Trade,
 - (i) Shed No. MOD - 2 is notified for storage of import Ammonium Sulphate, Gypsum, MOP, MAP, DAP and other such bulk cargo on recovery of storage charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates. All bulk cargo other than Gypsum will attract demurrage at rates specified in Section 3.1(B) of Chapter III of the Scale of Rates (SOR) from 181st day onward, whereas for Gypsum, the demurrage shall be effective from 241st day onwards.
 - (ii) Sheds L, K and N Grain Depot are notified for storage of import Ammonium Sulphate, Gypsum, MOP, MAP, DAP and other such bulk cargo on recovery of storage charges under provisions of General Bye Laws. The cargo will attract storage charges @ Rs. 20/- per sq. mtr. per day from 181st day onward, whereas for Gypsum, the demurrage shall be effective from 241st day onwards.
6. The above notification of sheds will be valid till 15.03.2022 and shall be reviewed thereafter.
7. These being bulk cargoes, the precautions for pollution control measures will have to be taken by consignees/their handling Agents, as would be intimated from time to time, during handling, transport, storage, etc.
8. You are requested to give wide publicity amongst your members to avail the facility.
