## CIRCULAR

Sub: Engaging 15 Retired MbPA Employees

Applications are invited from retired Labour Inspectors Gr. I / Gr. II to be hired on contract basis for a period of six months, extendable for another 3 months, if required, at the discretion of MbPA. The ex-employees should not be of age more than 63 years. The retired employees shall be from the Traffic Department.

- 2. The applications should reach to Establishment Branch, Traffic Department on or before 18.06.2024. Interested eligible ex-employees may submit application to "Deputy Traffic Manager, (Gen) in the enclosed format to Establishment Branch, 2nd floor Vijaydeep, Shoorji Vallabhdas Marg, Mumbai 400001 or through email on tm.hoestt@mumbaiport.gov.in".
- 3. The terms and conditions for engaging retired staff members on purely contract basis as approved by Competent Authority are as under.
- i) Duration of Contract will be initially for six months extendable for another three months, if required, at the discretion of MbPA.
- ii) Labour Inspector Gr. I. will be paid consolidated remuneration of Rs.25,000/- per month and Labour Inspector Gr. II will be paid consolidated remuneration of Rs.22,000/- per month. No other allowances or benefits would be admissible / paid.
- iii) They will have to work in shift duties with one hour recess as applicable for the shift with a weekly off. They will be eligible for 3 Closed Holidays i.e. 26th January, 1st May & 15th August.
- iv) They may avail 6 days Casual Leave during the contract period of six months. For any absence in excess of Casual Leave, pro-rata deduction will be made from the consolidated remuneration.

- v) The areas of work assigned to retired employees are specified here under
  - 1. Green Gate ID
  - 2. Ferry Wharf Passenger Terminal
  - 3. Eastern Waterfront + RoRopax + DCT
  - 4. FSPR Section
  - 5. WUDY / WINC

Besides the duties listed, they will be liable to perform any other work assigned by the superior in the interest of the Port.

- vi) The contract can be terminated giving one month notice in writing from either side. If the retired employee leaves without notice or acceptance of notice of termination the amount due to them, consolidated remuneration payable to the extent of notice period will be forfeited. However, the engagement is terminable on 24 hours notice, for unsatisfactory performance and for any act that is considered detrimental to the interest of the port.
- vii) Retired employee shall be responsible for the charge and care of Mumbai Port Authority Money, goods, stores and other properties that may be entrusted to them and will be accountable for the same.
- viii) Emergency medical treatment will be provided in case of accident while on duty at MbPA hospital / dispensary. No other medical facilities would be available to the employee and his family. They will be governed by the existing scheme for retired employees.
