**Sub: Implementation of Revised rates at Section 9.7,
of Chapter IX of Scale of Rates effective
from October 16, 2020.**

Tariff Authority of Major Ports (TAMP) has passed an order on 08.09.2020 for revision of parking charges for the usage of open area for parking of cargo / container handling equipment like Mobile Cranes, Forklifts, Reach Stackers, JCBs, etc. inside the Docks, stipulated at Section 9.7 of Chapter IX-Miscellaneous charges of Scale of Rates (SOR). This has been published in the Gazette of India extraordinary (Part III Section 4) on September 16, 2020.

2. Accordingly, the charges stipulated at Section 9.7 of Chapter IX-Miscellaneous charges of Scale of Rates (SOR) will stand revised and will be effective from October 16, 2020. The revised charges are as under :

9.7 Parking charges for the usages of open area for parking of cargo / container handling equipment like Mobile Cranes, Forklifts, Reach Stackers, JCBs, etc. inside the Docks
